This letter is to confirm our understanding of the terms of our engagement with for the tax year 2022 and to clarify the nature and extent of the service Acuity Business & Tax Advisors, LLC will provide. Also, by sending you the engagement letter, we have assumed that you are the person responsible for the tax matters.
